PARKS REPORT

SUMMARY/HIGHLIGHTS

The Phelan Park Enhancement is facing delays due to County approvals. Outstanding items include the Community Teaching Garden Greenhouse, irrigation, installation of pickleball nets, and remaining punchlist items. Completion is reliant on County approval, but completion is anticipated the end of August 2026.

Summer classes have concluded. Attendance was at record levels and indicates that more classes and programming should be made available next summer. Anticipated events for fall 2026 include continuation of Judo and Creative Lab classes, Phelan Phun Days, and seasonal baking and painting classes.

PARKS

- Pinon Hills Park has undergone extensive maintenance and cleanup. Three new trees have also been planted. A new irrigation system has been installed to save staff time hand-watering.
- New dog dispenser stations were installed at both Phelan and Pinon Hills parks.
- Pinon Hills CC (exterior) paint complete and gazebos/shade shelters have been re-painted.
- Weekly playground inspections now being conducted at both parks per best practice.
- Movies in the Park OT reduced by 75%.

COMMUNITY CENTERS

- Pre-rinse unit installed at Pinon Hills CC.
- New/fire-code approved Exit signs installed at both CC
- Abdul system serviced at Pinon Hills CC

UPCOMING PROJECTS/ MAINTENANCE- PARKS/STREETLIGHTS

- Staff will continue with summer maintenance.
- Quotes are being gathered to re-do Pinon Hills CC parking lot.
- Installation of a "Little Library" has been approved and will be installed at Phelan Park by two Girl Scouts seeking their Girl Scout Bronze Award. This has been put on hold until construction has concluded.

UPCOMING MAINTENANCE-CC

- Staff will continue with focused maintenance and improvements at Pinon Hills Community Center. Staff will be getting quotes to redo the parking lot due to safety concerns and will be installing some additional landscaping.

EVENTS - FALL

- Judo Classes, every Friday, and beginning in September, every Wednesday.
- Creativity Lab - Every Thursday after school hours.
- Baking Class - Ages 18+ Sept. 12
- Baking and Painting Classes will be held in October.
